

# RibaChat – Age Verification Policy

This document explains RibaChat's age verification processes and compliance with applicable laws and application store requirements (Apple App Store and Google Play). User safety and legal compliance are top priorities for RibaChat.

## 1. Purpose

This policy is implemented to verify users' ages and prevent individuals under the age of 18 from using the platform. RibaChat aims to ensure a safe and legally compliant user experience.

## 2. Age Limit

RibaChat is designed exclusively for users aged 18 and over. Individuals under the age of 18 are strictly prohibited from creating accounts or using the application.

## 3. Age Declaration

During registration, users are required to declare their date of birth. Once registration is completed, the provided information is assumed to be accurate and up to date.

## 4. Age Verification Methods

- Date of birth entry during registration
- Automated age screening systems
- User behavior and content analysis

- Manual verification when necessary

## 5. False Declaration and Sanctions

Users who intentionally provide false or misleading age information may have their accounts temporarily suspended or permanently terminated without prior notice.

## 6. Monitoring and Control

RibaChat regularly monitors user behavior and shared content to detect potential age violations. Accounts suspected of belonging to minors may be restricted until verification is completed.

## 7. Reporting Underage Users

Users may report accounts they believe violate the age requirement through in-app reporting tools. All reports are prioritized and reviewed carefully.

### **Additional Note:**

If a family member detects that a user under the age of 18 is using the RibaChat application, they are kindly requested to contact RibaChat through the official support channels. All notifications are handled confidentially and appropriate actions are taken promptly.

## 8. Data Processing and Protection

Data collected for age verification purposes is processed in accordance with the RibaChat Privacy Policy and applicable data protection laws. Age information is not sold or misused.

## 9. Legal Compliance

This policy complies with child protection laws and application store requirements. RibaChat cooperates with authorized authorities when legally required and promptly removes illegal content.

## **10. Policy Updates**

RibaChat may update this Age Verification Policy from time to time. Continued use of the application constitutes acceptance of the updated policy.
