This Privacy Policy has been prepared to explain the principles regarding the collection, processing, storage, and protection of personal data within the scope of voice and video chat services provided by the RibaChat mobile application ("App"). All users of the App are deemed to accept this Policy.

1. Data Controller

4. Legal Basis

- Explicit consent

5. Third-Party Service Providers

- **Agora.io:** Video and voice communication infrastructure, live audio and video streams
- **Socket.IO:** Real-time messaging infrastructure, message data processed on company servers

- **Backend & File Servers:** Profile pictures, media files, user data
These service providers have limited access solely for service delivery purposes.

6. Cookies and Local Storage

- No web cookies are used
- Local storage on mobile devices is utilized
- Tokens and preferences are stored only within the App

7. Data Security

- HTTPS encryption
- JWT authentication
- Bcrypt password hashing
- Role-based access control (RBAC)
- Rate limit protection
- Input validation

8. Data Retention

Data is:

- Deleted or anonymized when the purpose ends
- Deleted or anonymized when legal retention periods expire

9. User Rights

- Access to data
- Correction
- Deletion

- Data portability
- Withdrawal of consent

10. Account Deletion

Users can permanently delete their accounts:

- Mobile: “Delete My Account” option within the App
After account deletion, data is removed or anonymized except for legally required retention periods

11. Website

No user accounts are created on the website. Data submitted via forms and complaint areas are protected under KVKK.

12. Children’s Privacy

The App is not intended for users under 18 years of age.
